Coalition Meeting

Executive Committee Report

- Alabama Arise thanks all the Coalition members who helped plan and present the 2009 Health Care Access Conference on February 10.
- Alabama Arise has hired a new Health Policy Analyst, Anna Blair.

Project Reports

- Maximizing Enrollment for Kids Grant (PEAK) - ALL Kids and Medicaid have been awarded a Robert Wood Johnson Grant. The grant is for a four year period with the first phase being diagnostic. One proposal in the grant would be to work toward a paperless application system.
- Renewal and Retention—This

technical assistant grant has ended with both Medicaid and ALL Kids implementing several measures to try to improve renewal rates.

- Gaps Profile/Coverage Grant—Envision 2020 continues to work toward completing the pilot survey of the 5county River Region.
- AVAA—The Audio Visual Application Assistor System has gone "live" in Lawrence, Blount and Jefferson Coun-Mobile and Baldwin counties will be going on line
- Kid Check—The project continues to expand. For more information and a schedule of upcoming events go to www.alabamaruralaction.com
- The Birmingham Schools Initiative continues with over 7900 survey forms

returned and almost 1500 reporting they had no insurance and wanted an application. These applications have been distributed.

Local Projects

- The Jefferson County Coalition has decided to join forces with the Jefferson County Department of Health's Health Action Committee's Health Access group as both have similar goals. A meeting will be planned for later in the spring to develop future plans.
- The Mobile County Coalition met in November. The Coalition supported a Health Fair in October. Over 400 people attended. The Fair was held in conjunction with USA Pediatrics and USA College of Medicine.

- © Reauthorization of SCHIP will take effect on April 1, 2009. The bill provided sufficient funding for Alabama to continue to enroll eligible children.
- © The 2009 Health Care Access Conference held at Birmingham Southern on February 10th was very successful. There were over 300 attendees and feedback was very positive on breakout sessions.

Insuring Partner Reports

SOBRA Medicaid

- Enrollment—415,215
- Medicaid is currently operating under a hiring freeze and travel restrictions.
- Due to funding issues, Medicaid will no longer assist families by paying for birth certificates.

ALL Kids

- Enrollment-70,770
- Processing time continues to be over our 10 day standard.
- ALL Kids Regional Staff are seeing an increase in the number of Rapid Response meetings throughout the state.

ACCF

- Enrollment-7,550 with about 1700 on the waiting
- The decrease in the number of children enrolled was attributed to high claims amounts and an increasing number of applications received.
