INSTRUCTIONS FOR THE COMPLETION OF THIS FORM

1. File a separate form for each annual fee invoice
2. Complete all items as follows: (NOTE: Incomplete forms will be returned as unacceptable)

The license number and invoice number must be entered exactly as they appear on the annual fee invoice.

The licensee's name and address must be entered as they appear on the invoice. Name and/or address changes for billing purposes must be annotated on the invoice. Correcting the name and/or address on this form **does not** amend the license.

Check the appropriate size standard under which the licensee qualifies as a small entity.

Check one box only. Note the following:

- a. The size standards apply to the licensee, not the individual authorized users on the license.
